

Foundation of the working group MIBB (Minimally Invasive Breast Biopsies), Bern, Sep. 5th, 2008

Summary

- A working group within SGS/SSS is being founded. It will be necessary to change the by-laws of the SSS/SGS to include working groups. This will be a matter of the next meeting of the SGS/SSS committee on Sep. 10th in Vienna
- The president of the group is Elena Cauzza, Radiology, Bellinzona. She announced, that the secretary will be Sophia Venturelli, Ob/Gyn, Bellinzona. Finances should be managed through the trust center of the MIBB-group (see below)
- The whole group will meet once a year. As of Sep. 5th, the following persons will form the **core group**, which will meet several times during the year:

- A small group (to be defined) within the core-group will be responsible for Quality assurance
- Data collection: With just one abstention and no objection the whole group favours electronic data collection of each VB-case in a central database with the purpose of quality assurance
- Small modifications of the data sheet are proposed. They will be inserted and data collection sheets in four languages (e, f, d, i) will be provided. Major discussion about stereotactic core biopsies which might not be included in the presented data collection system. The discussion will have to continue within the core group.
- The proposed trust centre Adjumed Services with adjumed.net is being accepted. Initial costs of CHF 25'000.- and fees per case of CHF 25.- seem to be acceptable. A homepage (www.mibb.ch) will be initiated with the possibility of establishing a platform for scientific exchange. The trust centre should give administrative support especially for the yearly meeting, the core-group's meetings, handle finances and run the web site of the group. The electronic data collection has to be conforming to data protection. Different reports have to be generated and data extraction for individual purposes must be available. Plausibility checks and checks for completeness have to be provided.
- Sponsoring: The companies will be asked to give support for the initiation of the quality assurance program. Some financial support should also be provided from SGS/SSS.
- Member's fees: no fees will be due. Instead all members of the MIBB group have to be regular members of the SGS/SSS (www.senology.ch)
- criteria as stated during the consensus conference
 - o Qualification as specialist in Radiology or OB/GYN: surgery should be added
 - o MIBB-workshop and proof of successful biopsies on a phantom: Persons who have experience with more than 50 VB's do not have to attend a course. Members willing to establish new courses (besides Brun del Re's courses and besides the ones at IBUS Seminars and the Forums of the SGS/SSS) should present their program to the president before starting.
 - o 5 procedures under supervision if the person is working in an institution, where the method is established - 20 if not yet established: no change to these requirements
 - o participation in the quality assurance program of the MIBB group: no change to this requirement

- at least 12 MiBB / year / team member and at least 20 MiBB / year / team: no change to these requirements, although it is accepted, that these limits will be high for centres only performing US-guided VB's
 - entry fees for new centres: since every group has payed initially 2'200.- to 2'500.- and a later a second individual fee according to the number of performed biopsies, also new centres should pay the amount of CHF 2'500.- as initial fee.
- what to do with the old data and with the data of this year: In the main report of R. Brun del Re data of 2007 and 2008 are not included. Although data were collected with the purpose to answer financial questions, somebody of the core group should put the data together and publish the results in a scientific paper.
- jobs for the core group:
 - patient information sheets
 - guidelines for appropriateness and contraindications for VB's (stereo, US-guided, MR-guided)
 - algorithms for "risk lesions" (radial scar, papilloma, flat epithelial atypia) and for ADH, lobular neoplasia and DCIS.
 - guidelines for follow-up of "risk lesions"
